

Fisher's Rental Terms and Agreements

Rental Terms and Conditions

Fisher's Rental provides equipment under the following terms, designed to offer flexibility and clarity for our customers. These terms outline the duration, pricing structure, and usage allowances for each rental period. All rentals are subject to the conditions specified herein, and additional policies may be found on our Rental Policies page. For inquiries, please contact us at 610-372-4540.

Rental Term Options

Fisher's Rental offers the following standardized rental periods, each with specific pickup, return, and usage provisions:

1. Weekend Rental

- Definition: Equipment may be picked up or delivered between 7:00 AM and 12:00 PM on Saturday and must be returned by 9:00 AM on the following Monday.
- Pricing: Charged at a 1.5-day rate, inclusive of a 12-hour allowance on the equipment's hour meter.
- Alternative Provision: If equipment is collected between 12:00 PM and closing time on Saturday and returned by 9:00 AM on Monday, the rental is classified as a 1-day rental, with an 8-hour allowance on the hour meter.
- Overage: Usage exceeding the allotted hours will be prorated and charged based on the actual duration at the applicable rate.

2. Overnight Rental

- Definition: Equipment must be collected after 4:00 PM and returned or retrieved by 8:00 AM the following day.
- Pricing: Charged at a full-day rate, with a refund issued upon return the following day by 8:00 AM, with a 4-hour allowance on the equipment's hour meter.
- Overage: Usage exceeding the allotted hours will be prorated and charged based on the actual duration at the applicable rate.

3. Half-Day Rental

- Definition: Equipment must be returned or called off within 4 consecutive hours of pickup or delivery.
- Pricing: Charged initially at the full-day rate, with a refund issued upon return within the 4-hour window, adjusting to the half-day rate. A 4-hour allowance is provided on the equipment's hour meter.
- Overage: Failure to return within 4 hours will result in retention of the full-day rate; additional usage beyond the allowance will be prorated and charged accordingly.

4. Full-Day Rental

- Definition: Equipment must be returned or called off within 24 consecutive hours of delivery or pickup.
- Pricing: Charged at a full-day rate, with an 8-hour allowance on the equipment's hour meter.
- Overage: Usage exceeding the allotted hours will be prorated and charged based on the actual duration at the applicable rate.

5. Weekly Rental

- Definition: Equipment must be returned or called off within 7 consecutive days of delivery or pickup.
- Pricing: Charged at a weekly rate, with a 40-hour allowance on the equipment's hour meter.
- Overage: Usage exceeding the allotted hours or days will be prorated and charged based on the actual duration at the applicable rate.

6. Monthly Rental

- Definition: Equipment must be returned or called off within 28 consecutive days of delivery or pickup.
- Pricing: Charged at a monthly rate, with a 160-hour allowance on the equipment's hour meter.
- Overage: Usage exceeding the allotted hours or days will be prorated and charged based on the actual duration at the applicable rate

General Terms and Conditions

- **Proration Policy:** Fisher's Rental calculates charges based on the actual duration of equipment use. Overage time beyond the specified hour meter allowances or rental periods will be prorated and billed at the prevailing rate, ensuring fairness and transparency.
- **Return Requirements:** Equipment must be returned in the same condition as received, fully fueled and clean, unless otherwise arranged. Failure to comply may incur additional fees for refueling or cleaning, as outlined in our broader rental policies.
- **Payment Terms:** Full payment is due prior to equipment departure from our facility or upon delivery, unless a credit account has been established with prior approval.
- **Modification Clause:** Rental terms may be adjusted with mutual agreement, provided changes are communicated and finalized 48 hours prior to pickup or delivery.
- **Liability:** Customers are responsible for adhering to the usage allowances and return deadlines specified for each rental term. Fisher's Rental reserves the right to adjust charges in accordance with actual usage and compliance with these terms.
